The various tenderers who attended the pre-bid meeting have raised certain queries who have been clarified during the meeting itself. However, the following clarifications are furnished for certain queries raised during the pre-bid meeting

Q1. Group Life Insurance -Reg:

Clarification: Group Life Insurance has to be subscribed for Rs.2.0 Lakhs for each worker and the premium has to be borne by the contractor vide sl.no.05 of page.no.03 of 07 of NIT.

Q2. Requirement of the manpower- Reg:

Clarification: The approximate maximum strength of manpower may be taken as 150-200 numbers including probable attritions, additions/replacements for the information of all tenderers.

Q3. Charges towards uniform provided to all the manpower staff- Reg:

Clarification: The requirement of uniform has been made amply clear in para.no.5.52 of page.no.03 of 07 of NIT. All manpower staff shall be provided with two sets of uniform per annum of approved shade confirming to the weight of the fabric not less than 250GSM.

Q4. Monthly payment terms - Reg

Clarification: The payment will be made to the successful contractor per calendar month depending upon their number of working days in the calendar month.

Q5. Service charges for Bonus - Reg

Clarification: The actual amount of bonus distributed to various manpower will be reimbursed by the institute at no service charges and other statutory taxes.
